I. Investment Internship

- 1. Work with top asset management investment team and support team's daily work

- 3. Participate in investment conferences and meetings

II. Research Internship

- 1. Regular research work as a member of the research team;
- 2. Conduct fundamental research for overseas companies;
- 3. Assist Fund Manager in risk management and related work;

III. Finance Internship

- 1. Support the finance and operations team in regular work, including interactions with custodian banks, fund administrators, prime brokers, auditors, tax consultants etc.
- 2. Prepare and review fund NAV calculation, management accounts, and regulatory reporting for group entities;
- 3. Assist the finance and operations team in data analytics and automation.

IV. Compliance Internship

- 1. Assist in dealing with SFC and MAS for all compliance and licensing matters;
- Assist in developing and monitoring compliance-related policies and procedures as well as proper internal control to ensure that the Company is in compliance with regulations; Conduct KYC/CDD for new account opening and account maintenance;
